The Dauphin County Housing Authority provides 31 TBRA vouchers to homeless persons in partnership with the Dauphin County Office of Mental Health. The Office of Mental Health provides mental health services and case management for tenants involved in the PSH. An estimated 80% of tenants will remain permanently housed and maintain or increase income. Referrals come from shelter or safe haven for persons with serious mental illness. Street outreach may also identify people who are able to live independently but have substance abuse or serious mental illness.
