The 7 RRH program units are to assist families who are experiencing literal homelessness to move as quickly as possible into permanent housing and to remain and achieve stability in that housing through a combination of rental assistance and supportive services. We will also provide Supportive services to homeless individuals and families with disabilities, Mental health, drug diagnoses, substance abuse, and persons with Domestic violence with a particular emphasis on women and their children. Programming addresses appropriate treatment/intervention services for parents, as well as children's healthy emotional, social and cognitive development with particular emphasis on early childhood issues. Services are provided through a comprehensive integrated service system that addresses housing, substance abuse treatment, prevention and intervention, primary health care, mental health treatment, child development, life skills, transportation and an array of other wrap-around service coordination and collaboration.
