The Capital Area Coalition on Homelessness (CACH) is both the collaborative applicant and the HMIS applicant for PA501. HMIS in PA-501 includes six (6) HUD CoC-funded agencies, which have a combined total of fourteen 14 HUD CoC funded programs, and fifteen (15) state-funded and privately programs. In total, the PA-501 HMIS software is used by the nine (9) agencies/ organizations to track HUD CoC and ESG funded programs serving homeless, imminently homeless or chronically homeless individuals as well as households with children, adult-only, and youth only households. In addition, PA-501 has three Veterans programs using HMIS for Social Services to Families of Veterans. Some of the adults are disabled and some have co-occurring disorders, depending on the program requirements. The needs of the target population include safe, stable housing, as well as varying degrees of case management and support services that ultimately result in the household remaining stably housed. This includes but is not limited to behavioral health and physical health treatment, assistance with obtaining benefits and income and community resources such as mentors to ensure that the household can ultimately be permanently housed.

HMIS collects all the universal data elements as well as data necessary to generate APRs for all programs, ESG, HP and RRH, and CAPER reports and the information for the CoC application.

HMIS training of agency staff regularly takes place and we are now 100% through a staged implementation with all HUD programs.

HMIS is used for the Veterans by name list, special priority population by name list and the coordinated entry use of VI-SPDAT assessment tool.

Three (3) providers of PATH services began using HMIS.
