The project will rapidly rehouse victims of human trafficking and their families if applicable as well as those homeless unaccompanied youth with identifiable risk factors for becoming victims of human trafficking. Those youths under the age of 18 will be referred to the YWCA Transitional Housing program where there will be two dedicated beds for trafficked children. On addition to providing TBRA the YWCA will provide supportive services. The rental assistance will last up to 12 months depending on need. Supportive services may continue six months after the rental assistance ends depending on the needs and desires of the client. The project will coordinate with the YWCA's Human Trafficking Victim Services Coordinator (Dept. of Justice Office of Victims of Crime) for outreach and referral.
