Susquehanna Harbor Safe Haven, SHSH, is part of the continuum of care's plan to end chronic homelessness in the community. The safe haven houses 25 chronically homeless men with a mental health diagnosis. This is a low demand housing alternative for men on the streets, those in emergency shelter situations and those who are in precarious living situations. While there are several facilities in this community that address the needs of homeless men, none deal specifically with men who have mental illness AND who are chronically homeless. Harrisburg attracts many men who are looking for work and social services, bringing a variety of people who may become homeless. Men who are on the streets are generally dually diagnosed and often have a very difficult time finding employment, accessing social services, finding housing or even health care. The staff of SHSH work with many local social services agencies for referrals to the program and to provide other supportive services, including the county mental health case management unit and other agencies that provide similar services. The staff also connect residents with the employment programs of the YWCA Greater Harrisburg, Veterans' Outreach, the Center for Peace and Justice, the local housing authorities, local churches and any other agencies that assist in providing seamless services to the homeless. In addition to operating Susquehanna Harbor Safe Haven, Christian Churches United also partners with local churches to coordinate an emergency overnight shelter during the winter months. This outreach effort provides a good place to make connections with men who may be able to move into the supportive housing at the safe haven.

Susquehanna Harbor is divided into two floors. The first floor is semi private spaces; all residents must begin their safe haven stay on the first floor. Residents may become eligible to move up to the second floor once they have regular income, continue their mental health case management and continue working on other goals. The upstairs has separate living spaces, bathrooms and laundry.

The main goals of the program are to provide a safe, permanent housing situation and give supportive services so that residents can reach a degree of independent living. Our goal is to assist residents to obtain income, expand their life skills and/or increase their education or job skills at the resident's self-directed pace.

Two ongoing goals of the program are to maintain a high percentage of residents who successfully transition into independent permanent housing and to do sufficient outreach to keep a high occupancy rate for our bed space. Our specific goal for 2016-17 is to fill any empty bed within one month of it coming
