The rental assistance project provides tenant based rental assistance for 1 zero bedroom and 3 single bedroom units utilizing local landlords who are willing to lease to program participants. The Dauphin County Department of Human Services Mental Health-Mental Retardation provides mental health supportive services to participants.

Goals of the program are to retain 100% of participants in permanent housing for at least one year and to have 75% maintain or improve income.
