The veteran homeless population in this service delivery area is 12% and consists predominantly of males aged 50-65 years. To address the needs of this population, this permanent housing program provides housing first approach of offering one bedroom apartments to participants who are chronically homeless, with a verified disability, veterans. Case-management service is provided by working together with participants towards obtaining veteran benefits, income, employment where possible, and other self determination goals including education and life skills. To achieve this, the case manager networks and makes connections between the client and the area Veterans Association Medical Center in Lebanon, PA, Department of Social Security, Department of Public Welfare, and career link veterans representatives, and the YWCA department of labor VETS Homeless Veterans Reintegration (HVRP) employment program and Dept of Health and Human Services SAMHSA programs. Connections are also made with local veterans associations including Disabled Veterans of America, VFW, American Legion, and local county and state veterans representatives for their program resources, services and volunteers for our project activities. Housing is permanent, and all case management service goals are at the clients own pace based on the housing first and recovery health best practice models. The YWCA outreaches to chronically homeless veterans in wooded encampments, area shelters, area soup kitchens, weekly and annually holds two outreaches to connect veterans to the program and other resources: Homeless Veterans Stand Down Weekend Retreat, and Project Connect which is not limited but includes veterans. The project provides 5 beds with a total of 7 persons served over 12 months. 4 of 5 participants in the five bed units (80%) 6 of 7 total persons served over 12 months will remain in permanent housing.
