The data on all other tabs will then update automatically. You may need to enable automatic calculation in the "Formulas" tab of Excel.

Additional Notes

All of the sheets of this spreadsheet are locked by default except for the "PitRawData" sheet. Some advanced users may choose to make edits by unlocking the spreadsheet - the password to unlock the spreadsheet is "unlock" (without quotes). Users who unlock the spreadsheet may choose to unhide column that contain variable references. For most users, however, we do not recommend making edits to any of the formulas as this can make the template behave in unexpected ways. AAQ support cannot be provided to individuals who have edited formulas in this spreadsheet.

If, after pasting your data, you still see many cells showing "NO DATA" or experience other issues, we recommend that you redownload the latest raw data and template available on HDX.
